5.3 Children's Right to Develop in a Safe and Supportive Environment

Policy: Children have the right to a safe and supportive environment.

Background: Dr Montessori stated that a person's liberty is limited by the needs to other members of the community in which he moves. Man's "rights" are relative and bound up with responsibilities. Montessori Education concerns itself with removal of the obstacles that cause deviations to faculties during their formation. The physical treatment of children has greatly improved over the last 100 years however it is his psychic potential that one needs to explain to adults. Quite often barriers to the development of the child's psyche can be due to the adults' misunderstanding of the child's needs.

2	The Convention applies to everyone whatever their race, religion, abilities, whatever they think or say, whatever type of family they come from.
3	All organisations concerned with children should work towards what is best for each child.
15	Children have the right to meet with other children and young people and to join groups and organisations, as long as this does not stop other people from enjoying their rights.
19	Governments should ensure that children are properly cared for and protect them from violence, abuse and neglect by their parents, or anyone else who looks after them.
23	Children who have any kind of disability should receive special care and support so that they can live a full and independent life.
24	Children have the right to good quality health care, clean water, nutritious food and a clean environment so that they will stay healthy. Richer countries should help poorer countries achieve this.
28	Children have the right to an education. Discipline in schools should respect children's human dignity. Primary education should be free. Wealthier countries should help poorer countries achieve this.
29	Education should develop each child's personality and talents to the full. It should encourage children to respect their parents, their cultures and other cultures.
31	Children have the right to relax, play and to join in a wide range of leisure activities.
33	Governments should provide ways of protecting children from dangerous drugs.
34	Governments should protect children from sexual abuse.
36	Children should be protected from any activities that could harm their development.

- Safety and supervision are considered when designing classroom and outdoor environments.

Relationships

- Children are encouraged to work individually
- Children are encouraged to work in small groups
- Grace and Courtesy is modelled by staff and children.
- Staff talk to the children about the Charter of Respect.
- Staff are aware that supportive and positive relationships are important for child development.
- Staff speak to the children politely and respectfully at all times.

Staff

- No staff are to be under the effects of illicit drugs or alcohol.
- All staff are encouraged to have child protection training
- All nominated Supervisors and Persons in Day to day Charge at Elonera must have child protection training.
